ORDER
ELECTIONS OF SENIOR VICE-PRESIDENT, CHESS FEDERATION OF PAKISTAN

The Election Commission of the Pakistan Sports Board had earlier issued an Order dated 7th July 2025, postponing the election for the position of Senior Vice-President, Chess Federation of Pakistan, in compliance with the order passed by the Honourable Islamabad High Court, Islamabad on 3rd July 2025 in Writ Petition No. 2496/2025 titled *Saleem Akhtar vs. Federation of Pakistan*.

The Honourable Islamabad High Court, vide further order dated 18th July 2025, has directed that:

“Meanwhile, the result of elections shall remain subject to the final outcome of this petition.”

In light of the above direction and pursuant to the election schedule originally issued on 20th June 2025, it is hereby ordered that the election for the position of Senior Vice-President, Chess Federation of Pakistan, shall now be held on:

Venue: Committee Room, Pakistan Sports Board, Sri Nagar Highway, Islamabad

The election shall be conducted in accordance with the final voter list (**copy attached**) and final candidatures list (**copy attached**) as issued by the Election Commission on 2nd July 2025.

The result of the election shall remain subject to the final outcome of the Writ Petition No.2496/2025 pending before the Honourable Islamabad High Court.


