## **CIRCULAR**

Subject: **MISUSE OF TITLE "PAKISTAN BODYBUILDING FEDERATION" BY MR. TARIQ PERVAIZ**

I am directed to refer to the subject noted above and to state that Constitution of Pakistan Sports Board (PSB) 2022 is duly approved by the Federal Government (the Cabinet) in exercise of powers conferred under Sections 3 and 4 of the Sports (Development and Control) Ordinance, 1962. Rule 2(ix) and Rule 7(1)(xxxiii) of Constitution of PSB provide that only federations affiliated with PSB may be considered "National Sports Federations (NSF)", use the name "Pakistan" and send teams abroad. Non-recognized entities are not entitled to use name "Pakistan" or claim as NSF.

2. It has come to the notice of PSB that one Mr. Tariq Pervaiz is claiming to be the President of an entity styling itself as the "Pakistan Bodybuilding Federation". It may be noted that Mr. Tariq Pervaiz and the so-called bodybuilding federation he represents are not recognized by PSB. This entity is falsely using the name "Pakistan" and misrepresenting itself as a national federation for the sport of bodybuilding, despite not being affiliated with or recognized by PSB.

3. As such, any communication, activity, or decision issued by Mr. Tariq Pervaiz in connection with bodybuilding holds no legal validity and must be entirely disregarded by all relevant stakeholders, including federations, institutions, departments, and athletes.

4. In view of the above, it is requested that:

- All sports institutions, federations, and departments to disregard any correspondence, notifications, or decisions issued by Mr. Tariq Pervaiz regarding the sport of bodybuilding.
- Legal action may be initiated against individuals or entities found guilty of misusing the name of Pakistan or falsely claiming authority in violation of Constitution of PSB.

5. All stakeholders are requested to ensure compliance with these directives of PSB.
