The applications should be submitted through **EPADS** alongwith all information/ financial proposals and bidding documents and in accordance with the instructions to the bidders:

- i) Application on the company's letter head containing Name, Address, Telephone/Fax, Email address & branches office, if any,
- ii) Details / proof of National Tax Number/ firm on ATL and Registration with PEC.
- iii) Affidavit on judicial stamp paper, duly notarized to the effect that the firm has not been blacklisted and not in litigation with any government / autonomous agency.

The bid should meet the following criteria: -

- i) The bid security / earnest money equivalent to 2% of the quoted bid price shall be submitted in the form of bank draft/pay order/CDR in favour of **Director General, Pakistan Sports Board, Islamabad** on any working day during office hours.
- ii) In case of a bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security in the form of bank draft/pay order/CDR in favour of **Director General, Pakistan Sports Board, Islamabad** shall be sought from the successful bidder only up to the extent of a bid below 10% in the form of CDR/Pay Order. In such an event, the successful bidder shall be bound to produce the additional bid security within seven (07) days from the issuance of letter of acceptance failing which the Client / Procuring Agency shall forfeit the bid security of the successful bidder and may initiate legal action against the bidder.
- iii) The firm should meet the evaluation criteria as mentioned in the bidding documents.
- iv) Bidding will be carried out by adopting "Single Stage One Envelope" procedure. The proposals complete in all respects, in accordance with the instructions provided in the bidding documents should be submitted on or before 23<sup>rd</sup> September, 2024 and shall be opened on 24<sup>th</sup> September, 2024 at 1430 hours. If bids cannot be opened due to any reasons, then the same will be opened on 27<sup>th</sup> September, 2024 at 1400 hours OR 02<sup>nd</sup> October, 2024 at 1400 hours respectively. While other terms and conditions will remain the same.
- v) The competent authority reserves the right to accept or reject any or all bids as per PPRA Rule No. 33.
