#### **TERMS & CONDITIONS OF THE BID**

1. PSB intends to hire the services of a well reputed Security Company for provision of security services at Pakistan Sports Complex, Islamabad for a period of one (01) year renewable on yearly basis as per detail given below:-

- 3. Salient of single stage two envelop procedure are enumerated below: -

a.	PSB Islamabad will evaluate the technical proposal first without reference to the price and reject any proposal which does not conform to the specified requirements

### 4. Pre-Qualification - Mandatory: -

Company must furnish following information;

xiii.	Performance certificates by the major clients where your security company has been providing security services in the last three years.
xiv.	The company should have few licenses of automatic weapons and will provide at least 2 automatic weapons along with other weapons.
XV.	Weapons (12 bore shot guns) along with the personals.
xvi.	Certificate of handling of weapons by the company avail the personnel carrying the weapons.
xvii.	License holder personnel who are carrying the weapons / pistol who carries the weapons must have valid license.

- 5. Compulsory remittance of EOBI, ESSI and insurance premium against each individual.
- 6. Evidence of remittance of insurance premium will be submitted on award of security contract.
- 7. Payment will be made on monthly basis by PSB to the concerned company through cheque within a reasonable period on receipt of invoice. Payment shall be made after deduction of applicable taxes etc.
- 8. Security guards will be granted four days off per month by the company and substitute will be provided accordingly.
- 9. The company will be responsible to get each guard medically examined by a registered medical practitioner and provide medical certificate. Similarly, the company shall provide character certificates of each guard with verified antecedents.



- 10. Guards provided by the company should not be less than 25 years and not more than 45 years of age in case of guards. Bulky/overweight persons will not be accepted.
- 11. The guards should be trained and capable enough to handle the situation including but not limited to bomb blast, earthquakes and events of fire etc.
- 12. The company will provide a hand held metal detector and a vehicle search mirror at each location given at para-1 above.
- 13. Evaluation criteria is given in the technical proposal. Minimum passing marks forgualifying in the technical proposal is 70%.
- 14. In case first lowest pre-qualified bidder fails to provide the required services or PSB is not satisfied from the provided services, PSB reserves the right to obtain the services from second lowest bidder. Incase second lowest pre-qualified bidder fails to provide the required services or PSB is not satisfied from the provided services, PSB reserve the rights to obtain the services from the third lowest bidder.
- 15. The successful bidder will have to provide either ex-servicemen of young energetic and trained civilian fully equipped and conversant with security performance and other requirements as mentioned in the security agreement.
- 16. During the contract, the firm will provide Security Services as per terms and conditions, to be settled later on in the shape of contract agreement, for PSB, Islamabad.
- 17. An agreement will be made between PSB and contractor on judicial paper at **Annex-V**.
- 18. Availability of additional guards (if so required) will be ensured within 24 hours.
- 19. PSB may increase/decrease the number of security guards as per requirement on agreed rates of payments on same terms and conditions at the time of award of contract or after signing the contract.
- 20. Bids shall remain valid for 150 days after the date of tender opening. Earnest money will be returned to the unsuccessful bidders not later than expiry of the Bids.
- 21. The successful bidder will provide the security services as per agreed TORs within fifteen (15) days.
- 22. Director General, PSB reserves the right to accept or reject the tender without assigning any reason as per PPRA rules.

#### DRAFT AGREEMENT OF SECURITY SERVICES

This agreement is executed on this day\_\_\_\_for hiring of Security Guards between M/s\_\_\_\_Security Services (Pvt) Ltd, a company incorporated under the Companies Ordinance 1984 and having its registered office located at\_(hereinafter called "Security Company")

#### AND

Pakistan Sports Board (HQ), Islamabad (Hereinafter called PSB, Islamabad) which expression shall be deemed to include the "PSB" designated REPRESENTATIVE OF THE Second Part).

WHEREAS the First Party has security guards fully trained in the field of security has agreed to provide security services for the persons and moveable/immoveable property of Pakistan Sports Board (HQ), Islamabad, as set out in this Agreement.

#### 1. TERMS OF AGREEMENT

#### a. Period:

Contract renewal / extension on yearly basis will be subject to mutual consent and satisfactory performance of the company

#### b. Execution:

The security agency will be bound to execute the directives of the PSB.

#### c. Additional Guards.

In case PSB requires additional strength of guards, the security company shall provide the same according to requirement on the terms as agreed in the agreement on 24 hours' notice.

#### 2. GUARD SERVICES

The Security Agency will be fully responsible to provide satisfactory services at PSB.

- a) Energetic, smart, literate and healthy (preferably ex-serviceman) with complete uniform fully conversant with the security performance should be deployed at PSB in consultation with the security in-charge of the PSB. Guards provided by the company should not be less than 25 years and not more than 45 years of age. Bulky/overweight persons will not be accepted.
- b) Daily attendance will be marked in the register at the point as well as Daily Attendance sheet duly signed for submission to security in-charge of PSB for

calculation and compilation on monthly basis. Representative from the company / guards supervisor will randomly (at least four times a month) monitor the performance of guards as per terms and conditions and verify the same on attendance register.

- c) That M/s\_\_\_Security Company Ltd will provide and ensure that each guard on duty has received and understood written instructions for basic duties, is dressed in proper UNIFORM of the Company and is fully equipped to discharge his duties. Each guard is to be issued with two new uniforms.
- d) The Armed Guards will be called "Standing Security Guards" and will remain alert, patrolling and vigilant throughout their duty hours, and any mishap will be the responsibility of the Security Agency under all circumstances subject to the completion of all legal proceedings as required by law i.e. Joint Board of Inquiry etc.
- e) The company will be responsible to get each guard medically examined by a registered medical practitioner and provide medical certificate. Similarly, the company shall provide character certificates of each guard with verified antecedents.
- f) The company will be responsible to introduce a guard to the in-charge security officer PSB before deployment as a substitute.

#### 3. DEPLOYMENT OF GUARDS

Total ten (10) guards will be deployed; Five (05) Guards will be deployed at PSB different security posts in 1<sup>st</sup> Shift and five (05) in 2<sup>nd</sup> shift.

#### 4. PAYMENT OF SERVICES CHARGES

The PSB will pay a sum of Rs. \_\_\_\_\_\_ per month on account of charges of security services of 10 security guards with arms to M/s \_\_\_\_\_ Security Company Ltd by 10<sup>th</sup> of each month on submission of invoice and PSB shall not be responsible in any manner to pay either in cash or in kind to other than the amount of salary agreed upon in the agreement for the total strength agreed to be employed. Monthly wages of the guards will not be less than the minimum wages fixed by the government of Pakistan from time to time. Any violation at any stage in this regard will render the security company ineligible to work with PSB.

Evidence of remittance of insurance premium will be submitted on award of security contract. Payment will be made on monthly basis by PSB through cheque after production of EOBI and ESSI receipts.

#### 5. PERFORMANCE GUARANTEE

The successful bidder will be required to deposit a "performance/ bank

guarantee" equivalent to two (2) months remuneration of the first year, through a Pay Order/ bank draft in favor of PSB within one week of award of contract. #### 6. OVERTIME

The PSB shall not be responsible for any payment regarding overtime duty of the services provided by M/s\_Security Company Ltd.

#### 7. GUARD DUTIES INCLUDE THE FOLLOWING:

- a) Prevention of entry into office premises entrusted in the charge of M/s

  Security of any person not authorized by the PSB orany person who lacks proper identification.
- b) Prevent pilferage of items/equipment/property belonging to PSB from the premises of PSB placed under charge of M/s \_\_\_\_\_ Security Company Ltd as per written instruction issued by the authorized officer of PSB.
- c) Inform concerned authorized officer of PSB promptly and accurately any occurrence detrimental to the security of PSB premises placed under charge of M/s Security Company Ltd.
- d) To take appropriate action in case of emergencies like:
  - i) Raising of fire alarm and prompt communication to Fire Brigade and officer in-charge of the installation and arrange rescue activities.
  - ii) Forced Entry will be promptly reported to the local police station, in charge installation and the Control Office of M/s Security Company Ltd for appropriate action.
  - iii) Law and Order Situation will be promptly reported to the local police station, in charge installation and the Control Office of Company for appropriate action. All entry points be closed under such a situation.
  - iv) To arrange immediate medical coverage of any person injured in the premises.
  - v) To carry out daily checking of all security lights, entry points and locked premises for their effectiveness during off hours.
  - vi) To properly brief the relieving guard about any situation concerning security.
- e) The guards will perform duties including security of PSB personnel,

installation, its property and fire fighting in case of fire.

- f) It shall be the duty of security guard to take immediate remedial action at the time of any fire incident.
- g) It shall be the responsibility of security guards to check up firefighting equipment installed in PSB building/premises and report if found irregularity.
- h) During the effectiveness of this agreement in case of damage occurred to the property or personnel due to the outbreak of fire or any other eventually caused by the negligence of security guards, the contracting security company will be wholly responsible and liable for paying all the losses occurred to PSB as a result of their negligence, which will be decided by a committee consisting of both parties.
- i) The arms provided to the guards must be examined by a qualified armourer.
- i) Security guards will be granted four days off per month.\
- k) The company will provide a hand held metal detector and a vehicle search mirror at each location given at para-3 above.

b) If in the opinion of the PSB the presence of any employee of Company of any of his acts of omission or commission are prejudicial to the interests of the PSB to that of any of its officer, the PSB shall inform Company about such employee where upon will take immediate action against such employee by replacing him to the entire satisfaction of the PSB.

#### 9. <u>INDEMNITY</u>

a) Company shall at all times during the specified period of this agreement and thereafter indemnify the PSB and its officers against all losses and claims for injuries or damage to any person or property arising thereof or in

consequence of this agreement or any of its duties to be performed there under, or any act or omission of any of its employees, and against all claims, demands, proceeding, cost, charges and expense whatsoever in respect thereof or in relation thereto and all litigations, court processes and court cases and all proceedings there under filed or instituted by the personnel employed by M/s\_\_\_\_\_ Security Company Ltd or any of them collectively or individually or by any other party subject to completion of legal proceedings as required by law.

b) Company shall obtain from all of its employees who are rendering the services specified in this agreement, a declaration that they are and shall remain the employees of M/s\_\_\_\_\_ Security Company Ltd and shall have no obligation of contract with or claim whatsoever against the PSB oragainst any of its officials.

#### 10. CONFIDENTIALITY

M/s\_Security Company Ltd shall ensure that all of its employees Performing services specified in this agreement shall not at any time during the performance of this agreement or thereafter disclose to any person any information as to the affairs of the PSB or its offices and as to any other matter which may come to their knowledge by reasons of the performance of the services specified in the agreement. If in the opinion of the PSB there has been any such disclosure the person concerned shall immediately be dismissed from the service.

#### 11. RESPONSIBILITIES OF M/s SECURITY COMPANY LTD

- a) In addition to the services to be performed by M/s \_\_\_\_\_ Security Company Ltd. specified above Company shall provide at no additional cost to the PSB such supervision of its employees as is necessary to adequately fulfill its obligations under the agreement.
- b) Company is responsible for ensuring that all its employees performing the services specified in the agreement are physically fit, have no communicable disease and are healthy in all respects to perform duties.
- c) M/s\_\_\_\_\_ Security Company Ltd, is an independent contractor and accordingly is fully responsible for any accident or injury to its employees or cause by its employee and agrees that neither the PSB nor any of its officers will be held liable for either of the above in any manner.
- d) Company warrants that in the performance of its obligations under this agreement it shall comply fully with the laws applicable to the establishment of PSB.
- e) The employees of Security Company shall on no account indulge in UNIONISM.
- f) M/s \_\_\_\_\_ Security Company Ltd is responsible for recruitment, discipline and all other service matters of its employee. They will not in any case communicate with the officials of PSB regarding their service matter, which is the sole responsibility of Security Company.

- g) When circumstances warrant, the PSB may refuse to accept services from any employees of Company whose work has been found unsatisfactory or not in accordance with the requirements of this agreement. In addition, penalties / actions would be initiated in case of unsatisfactory performances and violations that are or equivalent to the ones highlighted below;
  - i) Amount of Rs.250/- per day per guard will be deducted in case of minor violations like wearing inappropriate dress/ late arrivals/negligence, attending guests during the duty hours, etc. "All fines and penalties will be deducted by PSB Lahore from the monthly payments of the Company.
  - ii) Three consecutive violations of same nature on part of an individual will render him unsuitable for performing duties in PSB Lahore.
  - iii) The company would be served with a warning notice in case of persistent minor violations and non-attendance of complaints. Three consecutive warnings may render the company unsuitable for performing security duty in PSB and PSB may terminate this agreement.
  - iv) Violations like offensive behavior that involves scuffling etc will lead to a penalty of up to 5% of the monthly bill. All fines and penalties will be deducted by PSB Lahore from the monthly payments of the Company.
  - v) Actions like firing of weapons which are not intended for the purpose of defense and in violation of security company's license may lead to cancellation of the agreement besides involving other legal proceedings as required.
- h) The process of recruiting, interviewing and hiring employees of Company including any actions with respect to alleged discrimination of other employment practices are the sole responsibility of Security Company subject to what has been agreed in this agreement.

#### 12. STATUS OF M/s SECURITY COMPANY LTD.

M/s\_\_Security Company Ltd is a bonafide limited company working for its own account and acknowledges that this agreement does not confer upon it, or upon any individual employed by it, the status of any employee of the PSB or that of any of its officers nor grants it, or any individual employed by it, any benefits not specifically provided for herein.

#### 13. **SECURITY**

Should such negotiations fail, the matter, as specified herein before subject to said exception shall be referred to arbitration by two arbitrators, one to be appointed by Company and the other by PSB and on their recommendations the third arbitrator will be appointed, to decide whose decision shall be final and binding and not challengeable in law.

#### 17. EFFECT OF AGREEMENT

This agreement embodies the entire understanding of the parties hereto on this subject and there are no commitments, terms, conditions or obligation, oral or written, express or implied other than those contained therein.

#### 18. TERMINATION OF AGREEMENT

If M/s\_\_\_\_Security Company breaches any terms and conditions laid down in this agreement and if such breach is not cured within thirty (30) days after receiving written notice from PSB specifying such breach in reasonable detail, PSB shall have the right to terminate this agreement by giving written notice thereof to the company, which termination shall go into effect immediately on receipt.
